EXPLANATIONS OF MEMBERSHIP:

The membership must be current to qualify for member fees. To ensure proper billing, please list the AQHA ID number and the name EXACTLY as it appears on the membership card. The record owner of the stallion is required to have a current membership when filing a stallion report in order to qualify for member fees. Through the payment of a membership fee to AQHA, I acknowledge that membership in AQHA is voluntary and I agree to be bound by all the terms and conditions of AQHA's Official Handbook of Rules and Regulations.

AQHA rules require the owner of the mare at the time of foaling to be a current member or pay nonmember fees for the registration of the foal to be completed. AQHA automatically charges for this membership to expedite requests.

Continuous membership is required for the individual participating in the Horseback Riding Program, Professional Horsemen and Breeder Referral Program.

*To qualify for the renewal fee, membership must be renewed within 30 days of the expiration.
